STATE FACTS TO ESTABLISH THAT A CRIME WAS COMMITTED: Defrauding a pawnbroker under Florida Statute ss 539.001(8)(b)(8) states "that the pledgor or seller of the item represents and warrants that it is not stolen, that it has no liens or encumbrances against it, and that the pledgor or seller is the rightful owner of the goods and has the right to enter into the transaction.

STATE FACTS TO ESTABLISH THAT DEFENDANT COMMITTED CRIME: Defendant entered into a pawn transaction at the above location, signed the transaction form, supplied a thumb imprint on said transaction form and received money from said pawnbroker for goods sold or pledged.
