

He is also monitoring SB 1630 and HB 7091 that standardizes penalty language which is crossed referenced in the various statutes enforced by the Dept. of Agriculture and the Consumer Services, including penalties relating to the Pawnbroker Act. This is an internal statutory transfer. Nothing changes. We will notify all members if there should be a call to action.

Paying with PayPal

There is another easy option for Paying your membership. On our website on the Join Now Page, there is a subscribe PayPal Button. With this button comes two options, First option, \$30 a month for the first store, and additional \$10 for each additional store. The second option, \$300 a year for the first store, and \$100 for each additional store.

The Subscribe PayPal Button will take from the payer every year or every month. For example, A Florida Pawnbroker paid on February first for \$300 a year. Every year on February First, PayPal will take from his PayPal account \$300, and same with the monthly option; however, they will take from him each month.

The Florida Pawnbrokers Association is still looking for board members. If you have what It takes to become an active part of your state association and


